# AGREEMENT

I (we) acknowledge that the "Rules Applying to DOG SHOWS" and The "Rules Applying to REGISTRATION And DISCIPLINE" and the "GENERAL REGULATIONS For HERDING TESTS & HERDING TRIALS" have been made available to me (us) and that I (we) agree that the club holding the Herding Test or Trial has the right to refuse this entry for cause which the club shall deem to be sufficient.
