Upper Midwest ASC is holding four conformation shows at the same location.

All non-aussie entrants must be registered with a tracking number from ASCA to receive titles. See ASCA website for details. You may also register for a tracking number at the trial. www.asca.org

Entries will be accepted in postmark order. In the case of duplicate postmark entries a random draw will be made of those entries to determine the order of acceptance. Correct entry fee must accompany an official, signed, and FULLY completed ASCA entry to be considered a valid entry. Forms are available on

the ASCA website. www.asca.org Day of show entries will be allowed if space is available. A waiting list will be established if the trial fills. Entry fees will only be refunded if the trial AND your spot is filled.

Directions: From the south: Take 35E north to Hugo/Centerville exit (#123B). Take clover-leaf and go right over the bridge. About a ¼ mile down, you come to a stop light. Take a right onto 20th Ave N. (Anoka Cty 54) Continue north 3.8 miles. (The road becomes W. Freeway Dr). You will come to an overpass. The house is the first house on the right after the overpass.

From 35W: go north to Hwy 97 Exit. Go left off the ramp and cross over the freeway. Take an immediate left on the frontage road, West Freeway Drive, (Anoka Cty #54), go South 2.5 miles. The house is on the left, white house with black trim. Box #13623.

THANKS FOR CLEANING UP AFTER YOUR DOGS.

The show is outdoors, rain or shine.

Note: There is no parking on the road. Drive in and find a spot to the immediate left or right of the driveway on the property.

No food booth this year. Anything you would want to eat available close-by in Forest Lake.

There will be NO electricity for RV amenities.

Show grounds will be available at 6:00 AM on Saturday July 19th.

No entry shall be accepted from a dog or handler disqualified from the ASCA Stockdog program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA.

All dogs six months of age or over at the show site must have a current rabies vaccine certificate in their owners' possession.

All Australian Shepherds six months of age and older must be able to show proof of ASCA registration to be eligible for showing

Dogs showing threatening behavior will be subject to either disqualification or excusal, per the ASCA Dog Bite Policy. All OASC investigations and appropriate forms will be forwarded on to the ASCA Business office. Dogs excused or disqualified under said policy, will be excused from the remainder of the events and asked to leave, without refund of entry fees.

Dogs **appearing** to show clinical symptoms of distemper, infectious hepatitis, parvovirus, leptospirosis, kennel cough or other communicable diseases will be asked to leave the event, without refund of entry fees
